# Ice In Paradise Figure Skating Club (IPFSC) Membership Information

**Membership Term:** Memberships are valid from July 1<sup>st</sup> of one year to June 30<sup>th</sup> of the following year. This is in order to synchronize with the membership term of United States Figure Skating (USFS) that we are affiliated with. If a membership is submitted anytime between July 1<sup>st</sup> and June 30<sup>th</sup> it still expires on June 30<sup>th</sup>. This is a USFS policy that IPFSC cannot do anything about.

**USFS Membership:** Your home club membership at IPFSC also enrolls you as a member with full privileges in USFS. There is no need to separately register for USFS membership.

#### **Membership Categories – First Family Member:**

**Home Club** – This class of membership registers you with both USFS and IPFSC. It gives you full competitive and test privileges. It also comes with a subscription to "Skating" magazine – a publication of USFS.

**Introductory** – If you have never been a member of USFS through any club at any time in your life you can join at a discounted rate for your first membership term (see above). This class of membership gives you full privileges in both USFS and IPFSC. This class of membership was established by USFS in 2011.

**Second Club** – If you are already a member of USFS through another club this membership category allows you to participate in IPFSC events.

**Professional** – If you are a USFS registered professional and you wish your home club to be IPFSC then this is the class of membership you should use. Note: You will still need to pay your USFS professional insurance fees separately.

**Collegiate** – If you are a full time college student this membership allows you to enjoy full privileges in both USFS and IPFSC for 4 full years of college at one low price. This membership class was established by USFS in 2011. Note: IPFSC requests a new membership form each year so that we can update contact information.

**Additional Family Members** - If you have more than one person in your family who wishes to join discounted fees are available for those additional members. Additional family members must reside at the same mailing address as the first family member. The second family memberships do not include a subscription to "Skating" magazine, but afford all other privileges of both USFS and IPFSC.

# Ice in Paradise Figure Skating Club Skater's Code of Conduct

As a member of our club, all skaters, coaches, and parents must adhere to this Code of Conduct at all times.

#### **General Guidelines:**

The Ice in Paradise Figure Skating Club is committed to creating a safe and positive environment for members' physical, emotional and social development and ensuring that it promotes an environment free of misconduct. This Skater Code of Conduct has been established to ensure the safety of all members using our ice to ensure quality practice time for all home club, associate, non-members and guests who purchase ice from the club and who participate in all club-related activities.

- 1. All skaters, regardless of whether they hold home club, associate, non-member or guest status, must follow and uphold the provisions in this Skater Code of Conduct regarding behavior on and off the ice. All club members are expected to exhibit good sportsmanship and be courteous toward their fellow skaters, coaches, parents/guardians of skaters, U.S. Figure Skating officials and guests.
- 2. The Ice in Paradise Figure Skating Club is committed to promoting a positive and friendly environment for all skaters. Remember "The Golden Rule:" treat other people like you want to be treated with respect.

#### **US Figure Skating General Rule 1.03**

Unsafe or discourteous behavior of any kind will not be tolerated.

"U.S. Figure Skating will not tolerate or condone any form of harassment (including sexual harassment), misconduct, (including sexual, physical and emotional misconduct), bullying or hazing of any of its members including coaches, officials, directors, employees, parents, athletes and volunteers — or any other persons — while they are participating in or preparing for a figure skating activity or event conducted under the auspices of U.S. Figure Skating."

#### **Ice Etiquette and Safety:**

- While in lesson or practice, it is the skater's responsibility to always be conscientious and aware of other skaters around them.
- 2. Skaters must skate with the flow of other skaters and familiarize themselves with the most commonly used areas for jumps and spins.
- 3. The only time a skater has the SOLE right of way is when they are skating their program to music. When you hear another member's music, please extend that person the courtesy and move out of their path momentarily. This only takes a moment and you will enjoy the same courtesy while you are performing your program.
- 4. Advanced skaters are expected to exhibit patience toward beginner members of the club. Remember, you were an inexperienced skater once, and it takes time for our future generation to advance to the point where they are completely comfortable skating with all levels of skaters.

I fully understand that this "activity" involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the "activity", the conditions in which the "activity" takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the "activity".
